**KISH BANK NAMES J. BRADLEY SCOVILL AS CHIEF  
OPERATING OFFICER**

STATE COLLEGE, PA – December 7, 2010 – William P. Hayes, Chairman, President and Chief Executive Officer of Kish Bank and its parent company, Kish Bancorp, has announced that J. Bradley Scovill, Executive Vice President and Chief Financial Officer of Kish Bank and Kish Bancorp, has been promoted to the additional position of Chief Operating Officer.

In this capacity, Scovill will assume direct responsibility for all day-to-day operations of Kish Bank and Kish Bancorp. His additional oversight responsibilities will include Human Resources, Operations and Service Quality, in addition to the areas of Profitability Management, Accounting, Technology, Facilities, Compliance and Risk Management, which he previously managed as Chief Financial Officer and Senior Risk Officer. Scovill is a member of the Office of the President and Senior Executive Team. He chairs the organization's Risk Management and Compliance Committee and the Asset and Liability Management Committee.

Prior to joining Kish in 2009, Scovill was an Executive Vice President of PNC Bank, a position which he held since PNC acquired Sterling Financial Corporation of Lancaster in early 2008, where he had served as Senior Executive Vice President. At the time of its acquisition by PNC, Sterling had \$3.2 billion in banking assets and \$2.7 billion in assets under management. During his 2000 to 2008 tenure with Sterling, Scovill served as Senior Executive Vice President with a series of responsibilities, most recently as Chief Revenue Officer, responsible for all Sterling operating units, including banking, leasing, specialty finance, wealth and investment management, brokerage and insurance. Previous to that he was Senior Executive Vice President, Financial Services Group, and before that, Senior Executive Vice President, Chief Financial Officer.

"Brad is a seasoned and effective senior bank executive who has positively influenced the management function at Kish since joining us a year ago. He has brought a strong team orientation and demonstrated excellent management, communication and execution skills. I appreciate the additional commitment he has made to serving Kish Bank and its affiliates as Chief Operating Officer and I am confident his talents and experience will serve the organization well in this expanded role," commented Hayes.

From 1994 to 2002, Scovill was President and Chief Executive Officer of Bank of Hanover in Hanover, PA, prior to and following its acquisition by Sterling Financial. Between 1991 and 1994, he was the Chief Financial Officer of Bank of Hanover. During the period 1981 to 1991, he provided financial, strategic planning, and credit quality consulting services with L. R. Webber Associates of Hollidaysburg, PA.

Scovill is a 1981 finance graduate of Penn State University where he was a three-year letterman on the football team. He has been active in community organizations including United Way, Easter Seals, the Chamber of Commerce and other economic development organizations, the Fulton Opera House, and the Hanover Public Library. His involvement in professional

organizations includes the Pennsylvania Bankers Association, the Smeal College of Business at Penn State, and Financial Executives International.

Scovill and his wife, Joanne, reside in State College. They have two adult children; a son, Clay and daughter, Marissa.
